

# SPECIAL EDITION WOOD DOCUMENTS ON UFOS

INTRODUCTION.

The files contained in this document represent only a portion of the files which are available on UFOs at the PUBLIC RECORDS OFFICE. What we show here are a sample of some of the most important ones which show that there is a cover-up. The reader must note the many names of the departments that investigated UFOs and note that in the 1960s, there were more departments at the MOD investigating UFOs than the forerunners of Airstaff 2a (Nick Pope & Kerry Philpotts departments - Nick Pope being the author of two UFO books and who maintains that his department was the only one which investigated UFOs.)

The departments which are listed are explained now.

#### PAGE 2

DDI TECH - Department Of Defence Intelligence Technical. This department features regularly as being involved in UFO investigations. It is an INTELLIGENCE department which means that it operated at a far higher level of secrecy than Whitehall MOD departments.

It is interesting that the DDI Tech branch investigated this sighting on their own.

#### PAGE 3

(Available in file AIR 20/9320)
Shows DDI Tech investigating more than one sighting report. It shows that this department was heavily involved in investigations and supplied its results to Whitehall. This means that Whitehall did not investigate, but liased with the investigating office of DDI Tech.

The sightings contained on this page are interesting in themselves as they are Radar Sightings of UFOs.

Note also the remarks that DDI Tech make in advising S6 on how to handle press matters or enquiries on playing down or rebutting these sightings. They were even advising S of S - which could mean Secretary of State. This means that DDI Tech amongst others were in charge of the UFO subject and its portrayal to the press. The existence of DDI Tech was kept secret for over 30 years until this file was released.

Chris Fowler regularly writes to the MOD with regards to the UFO subject. He was surprised when he had this first time admission to the Provost & Security Service based at Rudloe Manor having been involved in \*\*co-ordination\*\* of UFO reports. #### Unidentified Objects at West Freugh

- 1. On the morning of April 4th radar operators at West Freugh detected unidentified objects on the screens of their radars. A summary of this incident is given below.
- 2. The object was first observed as a stationary return on the screen of a rdar at Balacalloch. Although its range remained appreciably constant for about 10 minutes its height appeared to alter from about 50,000 to 70,000 ft. A second radar was switched on and detected the "object" at the same range and height.
- 3. The radar sets used were capble of following objects automatically besides being manually operated. The information is obtained in the form of polar coordinates but it can be converted to give plan position indication together with heights. This information can be fed into aplotting board which displays the position of the object by means of an electronically operated pen, while the height is shown on a meter.
- 4. The unidentified object was tracked on the plotting table, each redar being switched on to the table in turn to check for discrepancies. After remaining at one spot for about ten minutes the pen moved slowly in a N.E. direction, and gradually increased speed. A speed check was taken which showed a ground speed of 70 m.p.h., the height was then 54,000 ft.
- 5. At this time another radar station 20 miles away, equinced with the same type of radars, was saled to accompany the radar was "looked on".
- 6. After the "object" has travelled about 20 miles it made a very sharp turn and proceeded to move S.E. at the same time increasing speed. Here the reports of the two raiar stations differ in details. The wo at Balscalloch tracked an object at about 50,000 ft at a speed of about 240 m.p.h. while the other followed an "object" or "objects" at 14,000 ft. As the "objects" travelled towards the second radar site the operator detected four "objects" moving in line astern about 4,000 yards from each other. This observation was confirmed later by the other radars, for when the object they were plotting passed out of range they were able to detect four other smaller objects before they too passed out of range.
- 7. It was noted by the radar operators that the sizes of the echoes were considerably larger than would be expected from normal sircraft. In fact they considered that the size was nearer that of a ship's echo.
- 8. It is deduced from these reports that altogether five objects were detecte by the three raders. At least one of these rose to an altitude of 70,000 ft while remaining appreciably stationary in azimuth and range. All of these object appeared to be capable of speeds of about 240 m.p.h. Nothing can be said of physical construction of the objects except that they were very effective reflectors of radar signals, and that they must have been either of considerable size or else constructed to be especially good reflectors.
- 9. There were not known to be any aircraft in the vicinity nor were there any meteorological belloons. Even if helloons had been in the area these would not account for the sudden change of direction and the movement at high speed again the prevailing wind.
- 10. Another point which has been considered is that the type of reder used is capable of locking onto heavily charged clouds. Clouds of this nature could extend up to the heights in question and cause abnormally large echoes on the reder screens. It is not thought however that this incident was due to such phenomens.

S.6 (Mr. West)

With reference to your loose minute 511/S.6 deted 11th April, 1957, it is regretted that due to an oversight the West Freugh. Wigtownshire incident was listed twice; once as a newspaper report and once as a rader sighting under investigation. The error in listing the incidents means that there were fifteen reports this year. The newspaper reports were, in fact only two and not three as given.

2. The four reports, emplifications of which you require, are se follows.

#### Reder eightimes under investigation

- (a) A report was received from Royal Air Porce Church Lawford on 26th March, 1957 of a sighting of an unusual nature. The object move at a speed timed as exceeding 14/10 m.p.h. This is itself was unusual as the object had sentlerated to this speed from a stationary position. No explanation has yet been found for this sighting but supplementary report, including a copy of the reder plot, was requested and has been received from Church Lawford this afternoon.
- (b) Signals from Royal Air Force Stations Rempton and Lakenheath on 19th March reported unusual responses which did not resemble those from conventional sircraft. Aircraft sent to find the object made no contact with anything in the area of the response.

The meteorological office are at present trying to find whether any unusual phenomena were observed by their stations in that area.

It is possible that the response was due to a assemble phonomens known as "Angels" and "Anaprop" which is a result of Inversion and Reflection from the Ionosphere.

(c) Ministry of Supply, Bomb Trials Unit, Went Freugh, Wigtownshire picked up an unusual response from an almost stationary object on 4th April 1957; the object was tracked for thirty-six minutes continually increasing in speed while losing height. Enquiries, so for, reveal that no service nor commercial sircraft were in the vicinity at the time. We are at present trying to find out whether a private sircraft might have been in the area at the time.

The possibility of a belloon has been eliminated because the object was proceeding against the wind.

#### Hewapaper Report

- (d) A review by the 'Daily Worker' of a book recently published on German wartime weepons contained references to a German flying source which was flown at a speed of 1250 m.p.h. to a height of 40,000 ft.
- 5. The Wigtownshire report referred to in para 5 of our minute 3 of folder P.Q. 193/57 is the same incident as reported in the news cuttings forwarded with your minute and returned herewith.
- 4. It is unfortunate that the Wigtownshire radar incident fell into the hands of the press. The two other radar incidents have not been made public and reached us by means of official secret channels. We suggest that S. of S. does not specifically refer to these incidents as radar sightings. We suggest that in answering the original question S. of S. might reply:-

"Of the fifteen incidents reported this year ten have been identified as conventional objects, two contain insufficient information for identification and three are under investigation."

5. If supplementary questions are asked the S. of S. might wish to refer to the answer given to Major Wall on 4th May 1955. Reports received since that the answer given that there need be any change in the answer given at that time.

- 1. Thank you for your letter of 19 November.
- 2. If I may clarify once more, that the Ministry of Defence looks at reports of sightings of "unexplained" aerial activity in order to determine whether there is any evidence of a matter which might be of defence concern. If there is no such evidence our interest in the sighting ceases and no further official action is appropriate. To date the MOD is not aware of any evidence which might bestantiate the existence of craft or lifeforms of extaterrestrial origin, and no threat to the UK has been discerned which has been attributed to a "UFO".
- 3. Your letter mentions the role of RAF Rudloe Manor. Rudle e Manor is the Headquarters of the RAF Police, which does serve as a focal point, amongst other things, for flying complaints. In the past, Rudloe Manor was indeed the RAF coordination point for reports of "unexplained" aerial sightings. However, once received they were simply forwarded to Sec(AS)2 for appropriate action. Nowadays Rudloe Manor, along with other RAF stations, forward such reports directly to this office. I can confirm that RAF Rudloe Manor does not carry out any research into "UFOs" or any related matter.
- 4. I should now like to reply to your four specific points in sequence:
  - Q1. Abduction is a criminal offence and as such is a matter for the civil police to investigate. As regard "abduction by alien lifeforms", as the MOD is not aware of any evidence which might substantiate existence of extraterrestrial activity of the type to which you allude, this is a non-issue as far as the MOD is concerned.
  - Q2. I have looked through our "UFO" reports file for May 1994 and there were no reports of sightings of "UFOs" in the Swindon

Q3. As you clearly watched "Schofields Quest" you will have seen that the MOD gave a statement to the programme researchers, which was infact shown during the programme. Although we did receive a report of "two lights in the sky" from a witness in Crick, Matlock, at around 2330 hrs on 23 Aug 94, we were satisfied that there was no evidence to suggest that the sighting represented a matter of defence concern. There were no military aircraft booked into Night Low Flying training sector 3A on the evening in question. As you are aware, if there is no evidence which indicates a matter of defence significance there is no requirement, and we are not resourced, to undertake investigations to establish the precise nature of every seemingly inexplicable sight in the sky.

Q4. As with Question 2, I have looked through our "UFO" reports file for July 1994 and there were reported sightings of "UFOs" made to the MOD in the Wiltshire area.

Rudloe Manor was also termed as the HQ Southern Sector. It has a number of functions which are discussed on page 7 and 8.

Rudloe Manor is also an

underground command and control centre for the military. This means they have instant access to all the radar screens of military stations all over the UK and into Europe.

Interesting also about this page is it shows an investigation of a non MOD witness by offers of P&SS. These officers visited the lady in her home and told her not to talk about her sighting. Shades of Men in Black

Rerhaps th has happened on many other occasions with many more witnesses being silenced. Thankfully this one witness was able to be contacted by researchers and she is now prepared to tell us her story and the visitation she had from these men from the ministry.

#### PAGE7

This shows us a secret Telex from the MOD which shows that after it had been sent it was filed at CENTRAL REGISTRY, HQ SS (Southern Sector).

HQ SS was non other than Rudloe Manor which served as the command and control for Southern England as well as nowadays being a reserve command for national strike command defence at facilities like the Corsham Computer Centre, (CCC).

Note also the use of Signals Office to route messages regarding UFOs. Interesting also that Rudloe Manor houses No1 Signals Unit and the CDCN which is the master control centre for all MOD communications. there is no place with higher control of the MODs communications than this facility so it would be able to see all message traffic regarding UFOs. 2. Letter addressed to k.A.F. MINGOR from MIBS. AMER HUSSON, CHILLIS COD FARM, TRULL, TAURTON, describing an aerial phenomenon seen at night. A copy of Appendix "A" was passed by hand to the Investigator on 24th October, 1962, by Wing Commander C. M. GLBBS, O.B.T., D.F.C., O.C. Flying Wing R.A.F. CHIVENOR.

#### INVESTIGATION

- 3. CHILLISTOCO FARM lies & miles South West of TANNYON and is in a fairly isolated position.
- 4. MISS ARRE READIN, aged 16, said Appendix "B", that on 30th August, 1962 between 10.30 p.m. and 10.55 p.m. she opened the window of her room which faces N.N.F., and saw a diminishing star-like object with what appeared to be red and green coloured flames coming from it. It was slightly larger than the average star and appeared to be round. After about 21 minutes it became very small and she could only see it with the aid of Binosulars. She was quite sure that it was not the navigation lights of an aircraft because she had seen these many times and could recognise them immediately. She heard no sound at all. She told her mother and two of her brothers who looked at the object and, after some discussion, said that it must be a star. She made an entry in her diary concerning the matter. She did not look for it again until 17th October, 1962, when she saw the object again which was partially obsoured by fog. With the aid of binoculars she compared the object with several stars and noticed that the stars were silvery white whereas the object was red and green. She observed the object as the fog elenred and saw that it did not flash as does an aircraft's navigation lights but was both red and green at the same time, the colours being mixed together as if something was burning and giving off coloured flames. Near to and above the object she noticed another exactly similar but smaller object. She lost sight of both objects when the fog closed in. The following might 18th October, 1062 she saw both objects at 7.30 p.m. She noticed a difference in the colour of the original object which was now emitting green and orange flames in the same way as before. She took a "bearing" with her compass and noticed the object to be at 40° MAG, the second object was at 20° MAG. At 9.47 p.m. she again took a bearing; and found that the original object was now MAG and was now greeny-white in colour. The second object was now at at 70° MAG and was now greeny-white in colour. Both objects were still visible when she retired at 10. p.m.



Dear Mr Williams

Your letter dated 29 April to the Command Public Relations Officer about RAF Rudloe Manor has been passed to me for reply.

Flight Lieutenant Wright is the Public Relations Officer at Rudloe Manor and, in answering the letter in the Daily Mail of 25 April, referred directly to a question about the former underground aircraft engine factory at Hawthorn. He did not intend to give the impression that all of the tunnel complex at Box Hill owned by the MOD is now disused. It may be useful if I clarified the role of RAF Rudloe Manor.

RAF Rudloe Manor, which is part of Headquarters Logistics Command, has no direct operational role. Rather it supports a range of operational units within the area. Some of these units, as you point out in your letter, are housed underground.

The units supported by Rudloe Manor are as follows:

- The combined HQ of the Defence Communications System (DCS) and the Directorate of the Defence Fixed Telecommunications System (DFTS). DCS and DFTS provide a wide range of communications support for the MOD and since 1 April this year, incorporate the former No 1 Signals Unit (1SU). A small element of DFTS is located underground.
- The Controller Defence Communications Network (CDCN). CDCN is the tri-service organisation that controls world-wide defence communications. Most elements of the unit are housed underground.
- Provost & Security Services (P&SS). The police presence at Rudloe Manor comprises HQ P&SS(UK); the HQ of the RAF Police in the UK the equivalent of the Army's Military Police. The station is also the location of HQ(P&SS) (Western Region), who provide specialist police and


security support to all RAF establishments in the West Midlands, the West Country and mid-Wales.

- No 1001 Signals Unit (1001SU). Detachments of 1001SU are located at Rudloe Manor and Colerne in support of the UK constellation of Skynet satellites which provide communications to all 3 Services.
- Bristol University Air Squadron (BUAS). BUAS provides air experience and flying training for the cadets. The unit operates from the airfield at Azimghur Barracks at Colerne village, close to Rudloe Manor.

In addition to the units listed above, RAF Rudloe Manor is responsible for an extensive area of MOD owned tunnels in Box Hill which at one time accommodated the Station's war time operations centre and a large ammunition storage facility. With the exception of our operations centre, which is kept on a care and maintenance basis, these tunnels are totally disused and do no more than provide an escape route for the personnel who work in the units which are located underground. It is not MOD policy to permit visits by members of the public to Service Establishments. I am afraid it is simply not possible to agree to your request to visit RAF Rudloe Manor.

Finally, some 580 Service personnel and 250 civilians work at RAF Rudloe Manor and its lodger units.

#### PAGE 8

This is a letter by myself to request access to the claimed non-existent bunkers at Rudloe Manor. Note that one has to term themselves correctly when asking about such bunkers. The correct term is infact Underground Facilities. Asking

about bunkers gets you the response that there are no bunkers at the facility. That aside we can see what goes on in these facilities here in this letter.

My request to visit the facility was denied. I am currently trying a different tack.

The Rudloe Manor facility has about 800 staff working there as is stated in the official figures. What they don't tell you is the figures that are covered by the official secrets act. These secret figures for the Intelligence staff who work there probably number to a further 800 people.

Another interesting point from this letter is an admission to Rudloe Manor being the uplink site to the Skynet \*\*Communications\*\*
satellites. I think they aren't being
quite honest about the function. We
are currently gathering evidence to
show that Skynet not just a
communications system but a radar
tracking system which may be able
to track UFOs. This is an
investigation for the future.

#### Reports on Aerial Phenomena

The lt has been decided that sightings of aerial phenomena by Royal Air Force personnel are in future to be reported in writing by Officers Commanding Units immediately and direct to Air Ministry. (D.D. I. (Tech.)), with copies to Group and Command Headquarters. In addition, any reports from civilians received by units should be acknowledged formally in writing and copies of the reports themselves forwarded direct to Air Linistry, (D.D.I. (Tech.)).

2. It will be appreciated that the public attach more credence to reports by Royal Air Force personnel than to those by members of the public. It is essential that the information should be examined at Air Ministry and that its release should be controlled officially. All reports are, therefore, to be classified "Restricted" and personnel are to be warned that they are not to communicate to envene other than official persons any information about phenomena they have observed, unless officially authorized to do so.

3. This procedure does not apply to the radar detection of unusual targets which is to be reported through the normal channels as required by fighter Command Headquarters letter FC/8.45185/Signals, dated 13th January, 1953.

Thank you for your letter dated 14 April 1997.

I can confirm that AIR 2/16918 was in MOD's hands last year and was returned to the Public Record Office on the 9 November 1996.

I understand that the file was originally released, in 1994, in a sanitised form. It is established practice, when sanitising files, to ensure that pages thus affected are clearly identified, for example a photocopy of a page with sensitive information excluded would be marked "retained in department under Section 3(4)" or something very similar.

Following a change of policy in 1995 it was decided, in light of the Open Government initiative, our early concerns were no longer valid and previously excluded information could now be released. With the file already in the public domain the extracts were transferred to the PRO on 22 November 1995. Any subsequent action to re-establish extracted papers, either by re-inserting or attaching to the original file, rests with the PRO.

On the general question of extraction from files departments can remove papers for reasons of sensitivity prior to the opening of files. But once the file is open papers can not be removed, whatever the reason.

So far as your final question is concerned I regret that I can provide no further information as to what happened to the file after its arrival in the MOD.

I hope that you find the above information helpful.

This letter is a reply to my request for information about the missing file AIR2/16918. I was assured many times over the phone by Mr Goode that the file was with the MOD at the time stated - whilst at the same time we were getting conflicting reports from the Public Records Office. The moment we informed Airstaff 2a that we had caught them out over this conflicting information the spin doctors came out and revised Mr Goodes records which now state that the file was taken out one year earlier than first stated very sorry.... oh yeah. After many assurances that his records were correct, does it take an uninvolved department such as Airstaff 2a to tell to Departmental Records Officer that he doesn't know his job!

We have got our MPs on to the case and they don't like the things they are being told and quite frankly they don't believe the MODs new excuse for the missing file. We think we know why the file was removed from the Public Records Office and it has more to do with embarrassment over revelations about the secret UFO investigations departments being exposed than any thing else.
